This will help the LGAs to include this in their plans and budget. Formulate feasible M&E framework to Monitor fund utilization at the facility level.

I assure you that the PO-RALG will continue to work with you hand-in-hand to organize the upcoming conferences of this kind. As promised by the Deputy Vice Councilor (Academic) that the next conference will be held in Dodoma, we welcome you and we will be together in preparation of the same. This will enable them to learn and link their research findings and practical experience.

I also advice that, the policy maker (Ministry of Health) is important partner and they should be included when preparing the next year's Conference.
